**Inhalation:** If breathing is difficult, remove victim to fresh air and keep at rest in a position comfortable for breathing. Get medical advice/attention if you feel unwell.

**Suitable Extinguishing Media:** Dry chemical, CO<sub>2</sub>, water spray or alcohol-resistant foam. CAUTION: For fire involving UN1170, UN1987 or UN3475, alcohol-resistant foam should be used.

**Unsuitable Extinguishing Media:** CAUTION: All these products have a very low flash point: Use of water spray when fighting fire may be inefficient.

**Special Protective Equipment and Precautions for Firefighters:** Keep upwind of fire. Inhalation or contact with material may irritate or burn skin and eyes. **Personal Precautions, Protective Equipment and Emergency Procedures:** Use personal protection recommended in Section 8. Isolate the hazard area and deny entry to unnecessary and unprotected personnel.

**Methods and Materials for Containment and Cleaning Up:** ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area). All equipment used when handling the product must be grounded. Do not touch or walk through spilled material. Stop leak if you can do it without risk. Prevent entry into waterways, sewers, basements or confined areas. A vapor-suppressing foam may be used to reduce vapors. Absorb or cover with dry earth, sand or other non-combustible material and transfer to containers. Use clean, non-sparking tools to collect absorbed material. **Large Spill:** Dike far ahead of liquid spill for later disposal.
